### **Pool Safety: Keeping Summertime Safe and Fun**

The school year has ended and the summer season started. This is the time of year when children head outdoors seeking the sun and some fun. Many kids will find relief from the heat in a cool swimming pool, but parents need to be aware of the dangers that exist. If the appropriate safety precautions are not taken, pool-related accidents could occur resulting in catastrophic injuries or even death. No matter where the swimming pool is located – at home, a neighbor's house, a community park, or a hotel pool – parents need to be aware of safety hazards and take extra precautions to protect their children.

Many parents may not realize that children can drown in only a few inches of water and that most drowning incidents occur rather quickly and silently. In addition, not all pool-related injuries result in death; instead, some victims can suffer from a near- drowning accident and sustain serious injuries with long-range effects. These types of injuries can be devastating for the victims and their families. Many suffer from severe health consequences such as brain damage caused by the lack of oxygen suffered during the incident. These victims often times need life-long care for their permanent disabilities. In turn, the parents and caregivers are often faced with a great deal of emotional and financial stress.

### Drowning Leading Cause of Injury Death among Children Ages 1 - 4

To fully understand the significance of safety precautions in and around a pool, it is important to review the drowning statistics. According to the Centers for Disease Control and Prevention, each day in this country ten people die from drowning. Of those ten, two are children under the age of 15. Drowning is the second leading cause of accidental injury-related death among children ages 1-14 and the leading cause of injury death among children ages 1-4. Drowning injuries and deaths are not only preventable, but also predictable. These incidents can be prevented if the public is aware of the risk factors and take the necessary steps in implementing proper safety precautions.

## Protect Your Children from Pool Injuries with Safety Recommendations

There are many steps that can be taken by a property owner to prevent a serious swimming pool accident or drowning, including the following:

- Swim Lessons: If your child does not know how to swim, it is extremely important to make this a priority. Be advised, however, that learning how to swim is not a guarantee. Children can still drown, but knowing the basics of swimming may help prevent a drowning accident.
- Supervision: When taking your children to a pool, do not leave them unattended. A responsible adult should be designated to keep a watchful eye on the pool at all times. This adult should know how to swim and know CPR in the event of an emergency. Rescue devices need to be readily available. If a child cannot be located for any reason at all, always check the pool first.
- Installation of Safety Equipment:
  Homeowners are required to completely fence their pools with at least a four-foot high fence with a self-latching and self-closing gate. Pool covers can be also installed. In addition, alarms can be installed in a pool and also on the doors of homes with a pool.
- **Drain Covers:** The vacuum effect created by a pool drain can be powerful enough to hold a child at the bottom of a swimming pool. Make sure a pool is equipped with safe drain covers in order to prevent suction or entrapment injuries.
- Use safe pool toys and pool accessories: It is important that both adults and children use safe equipment when playing in or near a pool. Parents and pool owners should routinely check the United States Consumer Product Safety Commission's website to stay informed of any product recalls.
- No Diving in Shallow Water: Diving into shallow water commonly causes Pool injuries. These injuries usually involve severe head and spinal injuries, often resulting in paralysis from the neck down.
- No running around the pool: As expected, the surfaces surrounding a pool are wet from the splashing water and pose a risk of a slip and fall injury. In order to avoid this type of injury, pool owners should install a surface area around the pool that is slip resistant and creates some traction. In addition, homeowners should ensure that the pool area is free of any

obstacles that adults and children could trip over causing one to fall into the pool.



# Galfand Berger Attorneys Obtain Three of the Top 35 Settlements in 2011

Patton obtained three of the top thirty-five highest grossing settlements in the Commonwealth of Pennsylvania for 2011.

Rick had two of the top settlements. The first was for a worker who received multiple injuries to his arm

when it was caught in the power shaft of a canning machine. The accident was a result of a defectively designed machine, allowing it to operate with the power shaft

unguarded. Rick's second top settlement was for a machine operator whose arm was severely injured after it became caught between an unguarded point on a conveyor belt and roller.

Peter obtained a settlement for a carpenter who suffered

significant injuries after a hose from a concrete pump struck him in the leg. Peter

determined that the operation of the pump was in direct violation of the safety manual and that precautions were not taken to protect against foreseeable hazards.
