Rick Jurewicz Obtains \$2.5 Million Recovery for Hand Injury Case

Rick Jurewicz has another accomplishment to add to his long list of record-setting achievements: a \$2.5 million dollar settlement in Berks County, one of the largest settlements recorded there!

Rick represented a hardworking family man who suffered devastating injuries when his hand and forearm were pulled into a paper shredding machine. Our client had been a temporary employee at a recycling plant in Berks County. He was trying to clear a paper jam from the shredding machine, when a co-worker put the machine into reverse, pulling our client's arm right back into the shredder. As a result, our client's hand was amputated and he suffered severe forearm injuries as well.

Rick performed a careful investigation and learned that the

paper shredder machine lacked a guard attachment (a guard would have prevented the devastating injuries caused when the machine was put into reverse). Rick filed a lawsuit against the machine

manufacturer and seller, claiming that the paper shredder was defectively designed and unsafe. He was right. Rick settled the case prior to trial, ensuring that our client will have funds to help him and his family move ahead.

When you're hurt at work, the last thing you want to do is navigate the Workers' Compensation process. Too often, employers throw up road blocks trying to limit your benefits. Fortunately, the lawyers at Galfand Berger are here to help.

Part of our job is to make you aware of changes in the law and this article is about an important new development. In the past, a Pennsylvania worker who retired after a work injury may have lost his or her Workers' Compensation benefits. Employers argued that a worker collecting a pension didn't deserve workers' compensation because the worker never intended to work again.

All too often, the courts agree with the employers. However, the Supreme Court of Pennsylvania recently came out on the side of an injured worker in a new retirement case. The court said that just because someone decided to receive their pension does not mean they wanted to retire.

The facts of this recent Supreme Court decision explain why. In this case, the hurt worker was a police officer who started getting Workers' Compensation benefits after she was hurt on the job. The injured officer was awarded a pension because she could not return to her job as a police officer. However, she was capable of performing light or modified duty work. The police officer told the court that she took her pension because the employer had eliminated her light-duty position. In addition, the police officer told the court that she registered for work with the Pennsylvania Job Center. In other words, she wanted to work but the employer took away her job!

In reviewing these facts, the Supreme Court agreed that the employer did not prove that the injured officer intended to retire from work altogether; she just couldn't work in her police job and, for this reason, took her pension benefits. The Supreme Court ordered the continuation of her workers' compensation benefits.

This is good news! While the court's decision does not change the rule that employees who truly remove themselves from the work force may lose their Workers' Compensation benefits, it does require a more common sense approach in making



the determination of what constitutes retirement. It's important for an injured worker to make an informed decision before applying for pension or retirement benefits (including Social Security Retirement benefits) as this decision can have serious consequences down the road.

Over \$2 Million Verdict for Shareholder Pushed-Out from Company he Started

Galfand Berger helps injured workers. However, we also help small business owners hurt through the bad deeds of business partners and colleagues. Recently, Arthur L. Bugay won a significant shareholder oppression case on behalf of our client.

Shareholder oppression occurs when the majority shareholders in a company take actions that unfairly prejudice the minority shareholders. That's what happened in the case Arthur handled. Our client, Marvin Roffman, co-founded Roffman Miller & Associates, Inc. ("RMA") in 1990. Mr. Roffman was initially president of the firm and chairman of the Board of Directors.

By 2007, however, RMA was governed by a majority of the shareholders who excluded Mr. Roffman from its management team, prevented him from being a client advisor, and denied him access to a large client.

Mr. Roffman filed a minority shareholder oppression lawsuit

alleging that RMA's management team effectively excluded Mr. Roffman from the company and devalued the stock he held. RMA offered to purchase Mr. Roffman's shares for \$1 million, an amount that was less than half of the amount which RMA had previously declared to be a "fair" price.

After Mr. Roffman commenced his minority shareholder oppression lawsuit, RMA counterclaimed, alleging a theft of trade secrets, which Mr. Roffman denied.

A month long arbitration resulted in an award of **over \$2 million** to Mr. Roffman. RMA's countersuit claims were dismissed.
