Facebook: Lawsuits Allege the Company Endangers Children

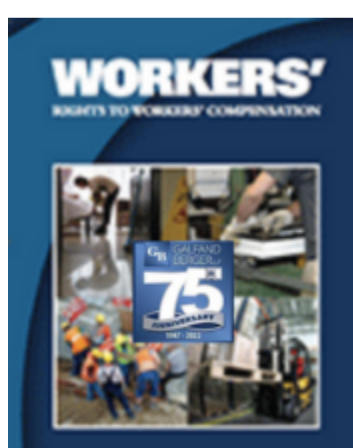
