\$10.65 Million Dollar Recovery for Fatal Workplace Accident

Galfand Berger attorney Richard M. Jurewicz recently obtained one of the highest settlements in Pennsylvania history: \$10.65 million dollars for two workers injured in a catastrophic accident involving a sulfuric acid tank.

This horrific accident occurred when a maintenance worker fell while climbing down a ladder and landed on a pipe carrying sulfuric acid. The pipe broke and sprayed the maintenance man and his coworker with toxic sulfuric acid, causing burn injuries to both men.

Rick's settlement is not only significant because of its size but also noteworthy because of the innovative way Rick achieved this major outcome.

After the accident, OSHA investigated and decided that the injured workers' employer was at fault. OSHA found that the involved ladder was previously damaged in that one of its rungs was bent.

OSHA also decided that the employer had not provided the injured workers with necessary personal protective equipment and, further, had failed to repair the sulfuric acid tank gauge for over a year. The employer claimed the accident was the workers' fault because they weren't following job safety procedures.

In other words, OSHA blamed the employer for negligence and the employer blamed the injured workers for the terrible accident that occurred. If these versions of the accident were true, Rick's clients would not be able to collect damages for the horrible injuries they suffered.

Rick didn't accept OSHA's story about what happened and he didn't accept the employers' story either. Instead, Rick conducted his own thorough investigation and discovered that there were other causes for the accident that ruined the


lives of his clients and their families. Rick learned that a contractor had been hired to install a new sulfuric acid tank a few months before the accident. He also learned that the tank was installed in violation of the manufacturer's instructions. He found that the contractor who installed the tank had no prior experience with sulfuric acid tank installations and didn't even know the industry rules. The discharge line was suppose to be supported and braced: however, the contractor and installer did not do what the manufacturer required.

Because of his aggressive investigation which left no stoned unturned. Rick was able to sue the tank manufacturer and two contractors for the improper sulfuric tank design and installation that contributed to the injuries of his clients. This compelling evidence led to Rick's extraordinary settlement prior to trial!
