Below are just some examples of the hundreds of cases that we resolved for our clients in 2025:

- **\$4,000,000** – Settlement against apartment building for negligent security.
- **\$1,680,000** – Workplace slip and fall accident resulting in a serious foot injury in Monroe County. Combined recovery through **Workers' Compensation** and a third-party **personal injury** claim.
- **\$1,515,000** – Fatal **car accident** in Berks County. Secured the maximum insurance policy limits for the victim's family.
